What is the Quality Assurance Program (QAP) and how is it administered?

The QAP encompasses a variety of initiatives that include pre-qualification requirements of Air Barrier Contractors and Air Barrier Installers to ensure they have a certain amount of experience to complete this type of work. Air Barrier Contractors must also meet minimum requirements for insurance, bonding and sign a Licensing Agreement dictating professional conduct.

The QAP developed by Building Professionals is updated on an on-going basis in order to streamline processes or enhance the

> NABA requires all Air Barrier Contractors to submit an air barrier contractor bid form and an awarded job notification forms to the NABA office. By knowing where the NABA-specified projects are taking place, NABA will strive to ensure that only NABA-Certified Air Barrier Contractors are awarded the projects.

REACHING NEW HEIGHTS WITH NABA

What do I get when I specify NABA?

When you specify NABA and the contract is awarded to a NABA-Certified Air Barrier Contractor, you will receive a level of comfort that the work will be performed in a quality fashion by NABA Trained and Certified Installers.

Every NABA specified project is audited by a third-party NABA Licensed Auditor. A NABA audit report is sent to all parties involved in the project including the General Contractor, Air Barrier Contractor, Material Manufacturer and Design Professional. The audits ensure the air barrier assembly is installed as per project specifications, and the materials are installed as per manufacturer's instructions and specifications. The number of audits is dependent on the size of air barrier contract in accordance with the requirements of the QAP manual and master specifications.

Specifying NABA is a win-win for all parties involved in the project including Building Owners, Air Barrier Contractors, Building Envelope Consultants, Air Barrier Manufacturers, Design Professionals, Air Barrier Material Distributors and General Contractors.

On the job

On a daily basis, NABA Air Barrier Installers perform adhesion testing, thickness testing (if applicable) and density testing (if applicable) to ensure the qualitative assurance installation practices of the air barrier material and record it on the daily job site reports.

Once the projects are complete, all daily job site reports are submitted to the NABA office for tracking and review by Quality Assurance Administrators.

Conflict resolution

If there is a concern on a project, NABA will act in a timely and professional manner to resolve the concern with any of the contractual parties. We will ensure the Design Professional receives the services that they specify. For example, if a air barrier contract was awarded to a non-NABA Air Barrier Contractor, we will contact the Design Professional to inform them of this if the Air Barrier Contractor informs us of this in due time.
